# **AMCHAM SENDS AN OFFICIAL LETTER WITH**

# 4 NEW PROPOSALS TO THE ALBANIAN GOVERNMENT

The President of the American Chamber of Commerce in Albania, Enio Jaço, has proposed four economic measures through an open letter to the Government.

Based on a questionnaire conducted with 220 members of AmCham and the work of the Tax Committee, Legal Committee and the Investment Committee, Jaço urges the Government to take difficult yet critical steps to support employers.

Some of them are planning adjustments to their workforce, so employer support is essential for employees and vital to them, their families and our economy. 99

The US Chamber of Commerce demands equal access to Covid-19 emergency funds for businesses of all sizes and the release of restrictive measures for them.

We want to emphasize the extraordinary importance of liquidity for businesses at this critical time, as well as the dangerous economic spirals that may come from its absence.

The Chamber also requires equal treatment with Unemployment Pay for employees regardless of the size of the company that is laying them off. Individual benefits should not be correlated with the size of the employer.

Delaying the tax prepayment for 2020 is emphasized as a necessity after the austerity measures taken by the Government in the fight against Covid-19.

We recommend uspension of tax prepayment and the adoption of a legislation that allows companies to make delayed payments in installments for all impacted industries. Local taxes, Social Security and Personal Income Tax should be suspended also for at

# least a period of two months. 99

In the open letter to the government, AmCham also called for the suspension of debts owed by businesses to the state, until their normal activity resumes. On the other hand, the government should reimburse as quickly and easily as possible all businesses that have VAT credit

Once again, AmCham has asked the Government to consult with stakeholders before making decisions that have consequences for businesses.



# ENIO JAÇO: ALL BUSINESSES SHOULD HAVE ACCESS TO LIQUIDITY

The President of the American Chamber of Commerce, Enio Jaco, once again raised the problems that big businesses are facing during the crisis caused by coronavirus pandemic. Their access to Emergency Funds, according to Jaço is essential for all businesses. This is also the main concern of 224 members of AmCham, according to an extended questionnaire they went through.

One of the main problems is maintaining liquidity. Businesses face a cessation or slowdown of activity due to the situation and a good part of them, especially in Albania, maintain operational money only for a short period of time. often only for one month. Imagine what could happen if these businesses can not work for 4-5 months." said Jaço. 99

Emergency funds can provide access in a variety of ways, according to Jaço, but what is important for big business is access to cash.

It's good to see big businesses not just as some abstract entities, but primarily as entities that employ people. The most vulnerable part of this crisis are the employees, who, if fired, can start a negative spiral in the economy.



The treatment of big business and small business should be similar, according to the head of the American Chamber of Commerce, because if a big business goes bankrupt, a very high number of people may lose their jobs and this will have a grave social impact.

# **CONDITIONS FOR BENEFITING**

Businesses must have closed down their activity or suffered a drop in turnover according to the list of entities affected by government decisions against Covid-19.

The list, which should have been attached to the Normative Act in the official state bulletin, is missing.

Businesses need to be able to repay according to the criteria of the banking sector, and the conditions and discretion of the second-tier Bank that will lend.

The funds will only be used to pay employees, according to payrolls processed in February.

Not benefiting from this scheme are all those (self-employed and small businesses) who have been treated from the payroll subsidy scheme, economic assistance or unemployment benefit do not benefit from this scheme.

Banks will apply the "first come, first served "criterion.

Within 10 days from the moment of application, the bank decides whether or not to approve the loan.

The Ministry of Economy and Finance can change the qualification criteria at any time, in agreement with the Second Level Banks, without retroactive effect on the loans granted up to that point.

# **LOAN CRITERIA**

The funds will be transferred to the account of the business employees, for which the bank receives all details of social and health insurance fund for each declared salary.

The value of the loan in no case exceeds the value of 3 gross monthly salaries of declared employees. In no case will the salary of an employee be higher than 150,000 ALL.

The lender will offer a preferential

interest rate, equal to the average interest rate of the last three auctions of 12-month treasury bills plus a margin of 0.5%, but in no case will the interest rate be higher se 2.85%.

The loan term cannot exceed 2 vears.

The Grace period lasts 3 months from the moment that funds are disbursed.

Under a government-approved template agreement, the Ministry of Economy and Finance guarantees 100% of the loan principal, but not more than the total borrowed from the business. Interests and penalties are in no way guaranteed by MFE.

The borrowing business must sign a Memorandum of Understanding according to which, in cases where the Ministry compensates the Bank for the amount that the Business has failed to pay, the latter agrees to make reasonable efforts to return to the Ministry of Economy the amount that it has paid the Bank, along with all the costs that may be associated with them.

Otherwise, the Ministry has the right to implement law no. 9665, dated 18.12.2006 "On state borrowing, state debt and state loan guarantees in the Republic of Albania" as well as other laws in force, to benefit the return of any compensation performed under the Guarantee Agreement.

If at the end of the loan period, according to the guarantee agreement, the business does not return the obligation to the bank, it loses the right to the shares which will be sold by the relevant structures according to the legislation in force.

# How payments can adjust to Covid 19- and support business



he coronavirus pandemic has recently brought Albania to its knees, giving a major blow to businesses and affecting consumer behavior in the Albanian market. For many businesses, the crisis has led to a decline in sales. But for some market sectors - telecommunications, digital media, technology, financial institutions, financial technology (fintech) institutions and the medical field -- there is an opportunity for innovation.

The economic consequences of this entire situation remain unclear. but the measures taken to combat the health risks are radical, creating real challenges for various industries. The World Health Organization (WHO) also raised the alarm on how paper cash could be a contributing factor to the spread of the COVID-19 virus (for example, China and North Korea stopped cash circulation until they could carry out a full disinfection of the notes). The number of internet searches pertaining to both "cash" and "virus" is at record highs. All of these developments have forced some businesses to immediately integrate digital payments and e-money into their business models and trade.

Even though the introduction of these cashless methods is overdue. the crisis situation has now forced Albanian businesses to integrate online technology into their strategies. The main reason people are



turning to online recently is for the most part, the limited mobility.

Online payment transaction volume is surging as consumers limited to their homes are turning to digital purchasing channels. Global ecommerce transactions were up 23% in mid-March compared with typical weekly volume.

In developed countries, consumers have been benefiting from these financial instruments for years. Well-known fintech companies -- PayPal, Amazon Pay, Apple Pay, Alipay and Google Pay, offer convenience in making payments and financial services, reducing costs and bureaucracies. The Albanian

market has several fintech players that enable customer convenience by using digital payments as well as other new financial solutions.

These companies help you pay for digital services such as utilities ( electricity, water bills, landlines bills etc), mobile topups, municipal taxes, internet and IPTV services, microcredit installment payments as well as paying for kindergartens and e-tickets. These services, especially utility payments, have been in high demand in recent weeks, so the number of digital payments, according to company statistics, has more than doubled last month.

Meantime more and more con-

sumers are shopping online for the first time in new categories, particularly groceries and household essentials. Retailers have already seen a surge in online grocery shopping as consumers stock up on food and other essentials.

To ensure Covid19 recovery in the most affected sectors, payments operators should reflect on how to help their business customers to accelerate the restart of their business.

#### **PAYMENTS COMPANIES MAY, FOR** EXAMPLE:

- Support the mass distribution of government relief payments.
- Ensure an easy online switching. They need to support businesses, especially SMEs by offering them the opportunity to overcome the crisis, mainly by offering the knowhow and enabling digital payments.
- Help businesses understand their customers' behavior and adapt their payment options accordingly.
- Simplify the B2B supply chain.

Latest regulation issued from Bank of Albania, which consisted on removing all fees related to local interbank transfers, was a very positive step towards business support. This will bring more usage of Ebanking channels and meantime will reduce their costs.

## FINDING THE NEXT NORMAL

As the crisis plays out, we will get more clarity about the depth and duration of the pain. One thing is clear now: there will be no return to the norms of 2019; the impact on the behavior and expectations of customers and businesses-indeed the entire fabric of the economy-will be profound. So it is critical not only for the payments ecosystem but also for the economy as a whole to develop, today, the payments solutions that will allow economies to emerge from the current crisis efficiently and define the post-COVID-19 future.

# COVID-19, FSA (AMF) requires insurance companies to suspend dividend distribution - Monitor.al

The Financial Supervisory Authority said it had recently required insurance companies to suspend dividend distribution procedures. The measure announced by the FSA comes as a result of the situation created due to coronavirus and according to the recommendations of the European Insurance Authority, it is required to maintain liquidity and financial indicators in the supervised markets.

# **European Bank for Reconstruc**tion and Development (EBRD)

European Bank for Reconstruction and Development (EBRD) in a recent report on the country's resistance against the Covid-19 pandemic,

found that tourism in Albania is the most endangered, due to the high weight it has on the economy, with over 20 % of Gross Domestic Product. But there is still hope that tourism will work this year. It is at our neighbors, Kosovo, but also in Macedonia.

# DCM approved/ How will the loan guarantee work for big businesses - Monitor.al

According to the approved terms of the Council of Ministers' decision, the Loan Value made available by banks for every Business participant, may vary according to the Business demand, but it should not exceed the value of three gross monthly salaries of employees declared by the Business.

# **Taxes: Where to complain when** you have problems with receiving financial assistance - Monitor.al

The General Tax Directorate informs all the interested parties, who consider that they may be beneficiaries of financial assistance, but their request has been rejected, that they have the opportunity to submit their request / complaint by communicating through the e-mail address of the Regional Tax Directorate, where they reside.

## **COVID-19** crisis, the number of unemployed may increase to 50-60 thousand people within a month - Monitor.al

The number of unemployed in the country, due to the closure of businesses to prevent the spread of coronavirus, may increase to 50-60 thousand people within a month. According to Minister Denaj, for the category that loses the job, the Government will provide assistance as much as half of the minimum salary in the country, which is at the level of 27 thousand ALL.

# **Taxes: Deadlines for declaration** and payment of tax liabilities have not changed! - Monitor.al

The Tax Administration brings to the attention of all taxpayers that the deadlines for the declaration and payment of tax liabilities have not changed. The first deadline of the declaration is April 10, when all VAT entities must submit electronically, via e-filing, the Purchase and Sales Books, for the period of March 2020.

Technical control of vehicles continues to be closed due to coronavirus pandemics.
