Letter from Minister of Finance and Economy

Dear Readers

It is a beautiful tradition to share with members of the American Chamber of Commerce, achievements, challenges and future plans, through this annual book. However, 2020 has definitely not been a normal year. COVID 19 has led the global economy to face one of the greatest shocks ever. The positive efforts to control the spread of the virus, led to shuttering of the businesses and significant contraction in the global economy.

Due to the exceptional nature of the crisis, all governments have deployed a massive support to preserve their economies, in the form of direct spending or guarantees, as lockdown measures deeply affected businesses' activity and households' revenues. Health spending has also significantly increased to cope with the pandemic.

Albanian citizens have faced two consecutive emergencies, the devastating earthquake of November '19 and the pandemic. The necessity to protect citizens brought changes on the way we carry out our daily life or economic activities. Emergency measures and rapid intervention taken by the Government of Albania with important actions in support of low income individuals, employees and businesses after the lock down, were considered imperative to avoid poverty increase or business closure. The financial packages and guarantee schemes have supported around 300 thousand Albanians in the country.

As foreseen, fiscal measures brought an increase of debt to GDP ratio, deviating temporarily from our main objectives of fiscal consolidation. Nonetheless, during 2019, Albania continued to progress through reforms and priority projects. The Government managed to have a reduced level of debt to GDP to 66.2%, positive primary bal-

9%. Foreign Direct Inached over one billion a row. Unemployment

ance and deficit of 1.9%. Foreign Direct Investments in 2019 reached over one billion for the second year in a row. Unemployment rate was 11,4% at the end of the year.

Positive and stable macroeconomic indicators, were recognized also from international markets as we successfully issued the Eurobond in 2020.

The Government has intensively engaged to conclude reforms improving business climate, building upon results in the last years. Today, one can register a business in Albania, online and within a day.

The deregulation reform, simplification of procedures, processes and documentations was on focus during 2019. This allowed us to implement the Digital Revolution from January 2020, providing online services through e-Albania for citizens and businesses. Trade facilitation has continued through the project of Paperless Customs, new protocols and free trade agreements. Several licenses, considered unnecessary are not required anymore. Businesses and citizens today spend less time in submitting or requesting official documents and receive a far better service then few years ago. VAT reimbursement reached the highest levels in 2019, at 200 million USD with no stock at the end of the vear. Every achievement, represents thorough communication with the private sector, which we aim to intensify throughout new priorities and initiatives.

In our efforts to recover from the pandemic, fiscal policies with accompany the Government, but foremost the private sector. After the introduction of 0% profit tax for small and medium enterprises, only 9% of businesses will pay a profit tax of 15%. Support and assistance to invest in strategic sectors will continue for every Albanian or foreign investor.

We expect the Albanian economy to return on the growth trajectory in 2021, despite the announced recession in 2020. The reconstruction plan from the earthquake, investment mobilized through the state budget and private sector, are expected to have a positive impact on growth and employment.

Crisis provide opportunities, and together we shall be able to provide a new track of development for Albania. New opportunities are opened to businesses to invest; this is the case of digitalization, green energy or the adaptation of health system. Our common investment in education, training and R&D will create new skills to adapt to new challenges.

Everyone is needed to reach these ambitious targets. Creativity, technology and the proactive engagement shown from AMCHAM members throughout these 20 years in Albania, are a successful model to be pursued for a prosperous recovery and future for our citizens.

2019 was a year of important changes for AmCham. With the election of a new President and Board members,





As an organization committed to furthering the development of business relations between US and Albania, AmCham considers the adaption and promotion of fair and ethical business standards and good cooperate citizenship as key goals in its work and interaction with others. AmCham takes an active and leading role in promoting best American practices towards the business community operating in Albania by adopting this Code of better business principles and practices. The Code is to be utilized by AmCham and its Member Businesses in every aspect of their operations:

Government Engagement:

Member Businesses shall respect the rule of law in their engagement with the government: Respect laws and regulations and adhere to the rule of law: Refrain from engaging in any other activity that may be construed as corrupt or in violation of the law; Refrain from attempting to influence any interests through the exchange of gifts, money, or Information: Refraining from asking for special treatment based on improper use of personal relations while conducting professional activities.

Business Conduct:

Member Businesses shall engage in fair and ethical business practices: Uphold the law in exercising their business activity and conduct business transparently; Neither accept nor offer any form of bribery in conducting business: Refrain from providing false or misleading information and honestly represent themselves in discussions and negotiations; Apply environmentally responsible business practices

Employee Conduct:

Member Businesses shall provide a safe and ethical working environment: Guarantee fair treatment of all employees and show respect for the individual and dignity of the worker; Provide a safe and healthy working environment in the workplace; Tolerate no embezzlement or profiteering; Employees shall refrain from engaging in behavior or activities that may unfairly compromise the reputation of another employee with the company; Employees shall conduct themselves in such a way that brings honor and respect to the organization.

Community Contribution:

Member Businesses shall play an active role in the community: Act responsibly and demonstrate a commitment to the advancement of the community through the promotion of education, health, cultural and other activities: Whenever possible, encourage employees to give back to the community through volunteering their time or resources.

January 23, 2019 -

Business Forum with the General Director of Customs, Ms. Belinda Ikonomi

AmCham held its traditional meeting with the head of the country's customs administration to start the year, enabling member businesses to have a direct line of communication with this important institution. The meeting focused on several major issues businesses face while interacting with the customs system. AmCham members discussed the new Customs Code and spoke about their user experience during clearance procedures and interaction with the customs administration.

February 13, 2019 -

Business Forum with the Vice General Director of Taxes, Mr. Xhavit Çurri

AmCham organized its annual meeting with the General Director of Taxes to kick-start the yearlong collaboration with the tax administration with a focus on Issues such as fiscal evasion, the IT system, decisions related to the appeal of tax inspectors, VAT refunds and general tax procedures and documents required by businesses for everyday transactions. In addition, emphasis was placed on the absence of guiding instructions related to the introduction of new legislation.

of Customs. Representatives of Am-Cham stated that beyond reference pricing, issues related to the import of fake goods were a real problem for companies who hold the patent of these goods. In addition, AmCham informed the Director that procedures related to the reassessment of the value of goods at Customs remains a problem for our members. Also, they discussed the need for a new appeals department where claims can easily be filed and for an online portal where businesses can check the status of their goods and where rules and procedures are communicated and kept up to date.

June 28, 2019 -

AmCham celebrated the 243rd anniversary of the Independence Day of the United States of America

AmCham Albania celebrated the U.S Independence Day in the company of 850 guests. Among the participants present, were members of AmCham and the U.S. community to Albania. A live band, typical American food, entertainment and the majestic fireworks were the elements that accompanied the celebrations of the most important day in the history of America.

They discussed Cash payments and the issue with the lack of banks in parts of Albania's territory and also lack of internet services in about 8 percent of the country, which makes it practically impossible to apply these articles.

The "Back to Work" event brought summer holidays return to work and background, this networking event had an exhibition of old photos that back to 1918-1920. Albanian-American historian, Mr. Auron Tare, spoke during that time.

October 16-19, 2019 -

New to this year's event, was also an AmCham Best Practice Award. AmCham met with Deputy Finance Minister Sorensen and Chief Inspector Seferaj

AmCham's Labor and Ethics Committee invited Deputy Finance and Economy Minister Ms. Dajna Sorensen and Chief Labor Inspector Arben Seferaj to a joint meeting with AmCham members to discuss issues arising from the implementation of the Labor Code and the Law on Employment and the effect on business-labor administration relations during inspections. AmCham's lobbying efforts have produced the most headlines in terms of news stemming from the Chamber's activities in 2019. AmCham has channeled the views and concerns of its members through professional arguments, finding the best solutions that not only help the AmCham community but also improve the general business climate in Albania.

We have addressed concerns of different industries as well as challenges faced by businesses on key issues that affect the business climate in Albania.

AmCham's 20 years of experience, combined with the expertise of its Committees, guided the Chamber in its discussions with the government and parliamentary bodies on law-making processes and the impact of changes in legislation on businesses.

The Fiscalization Law drew great efforts by two AmCham Committees -- Legal and Tax -- which put together comments on the law. AmCham finalized these comments and presented its requests at official meetings with the Ministry of Finance.

The Fiscal Package also came under the focus of the Tax Committee, which put together a 23-page document to channel all member concerns and requests related to the 2020 Fiscal Package. Issues relating to Article 27/1 of the Income Tax Law were highlighted in the document, with the Chamber lobbying to make sure double taxation agreements would supersede local legislation. Respecting international agreements helps much needed foreign direct investment.

The implementation of the Law on Local Government and related issues raised by AmCham members on how the law is being applied guided AmCham in

its remarks at the Investment Council meetings, where it discussed how local government taxes are being applied and on the need for transparency in the way these tax revenues are being used.

AmCham also focused its efforts in lobbying on behalf of several industries, dealing with issues that affect their day to day operations. These included lobbying in Parliament on behalf of the food industry following changes to the Criminal Code that would hit the industry with stricter penalties as well as lobbying on behalf of the packaging industry over unfair competition in the market through changing tariffs on plastic raw materials.

AmCham also took part in numerous discussions with the Ministry of Health related to the new Law on Health which affected the tabacco industry.

Protecting the interests of member businesses is not done through lobbying alone. AmCham carefully monitors all proposed legislation changes as well as actively participates in commenting and making suggestions on new draft laws. To convey the opinion of AmCham's experts to the right audience, the Chamber is a member of the Investment Council and the Tax Council, where it channels the voices and opinions of its members in a professional manner.

Committees underwent qualitative change in 2019, creating and rebranding committees to reflect the specific topics on which AmCham works.

The Tax and Customs Committee deals with the two specific areas in its name and the related regulatory bodies -- which are very important elements for doing business. The Labor and Ethics Committee focuses its attention on HR issues and has opened up a new framework for AmCham's engagement with the community by promoting business ethics. The Legal, Regulatory & IPR Committee's activity

will encompass any issues dealing with legal and regulatory procedures without leaving aside the pressing IPR concerns. The American Chamber of Commerce in Albania has also created the Trade and Investment Committee which will have plenty of work ahead in lobbying to strengthen the business climate, to boost investment incentives and improve the rule of law -- all key elements in attracting investments.









"This Committee's aim is to monitor and analyze important changes and developments in tax legislation. It shall seek not only to inform members of changes, mainly related to taxes, but also to contribute with expertise in interaction with government institutions related to the legislative landscape. It shall further engage with Customs authorities to streamline procedures and controls with the goal of reducing red-tape and costs for members. It shall collaborate closely with the other Committees as well." on matters of commons interest.

In 2019, the AmCham Tax and Customs Committee continued its dialogue with top officials at the tax and customs administrations, providing information on issues that arise from day-to-day business activities but also holding preliminary discussions on major legislation pieces like the Fiscal Package, the Law on Local government as well as other government-proposed changes in legislation. The committee also serves as a resource to members providing training on the latest information from the tax and customs directories.

The committee also lobbies, raises awareness and drafts strategies on IPR-related issues. The Committee also covers public procurement processes and works closely with other committees."

The Regulatory, Legal and IPR Committee had a broad spectrum of activities in 2019, dealing with issues affecting procedures, laws and regulatory systems that govern business activities. The Committee's work plan helped build stronger institutional relationships between AmCham and government institutions.









"The Committee aimsto address issues related to the management of human resources, compliance with labor regulations and laws, the Labor Code, HSE, Code of Ethics andanti-corruption practices. The Committee actively engages on issues related to Business Ethics andcooperates with many stakeholders in order to address issues related to HR management. During 2019, the HR committee's main focus was on the importance of Labor relations and education to businesses on business ethics. "Enhancing investments and trade are the key goals of AmCham. Thus, this Committee focuses on the facilitation of trade and investments, be they domestic or FDIs, and the improvement of the overall business climate. It contributes to and monitors the AmCham Business Survey . The Committee also aims to work towards identifying the competitive advantages of Albania (e.g. in the form of a study). Finally, the Committee shall seek to engage with other AmChams in the region to build a dialogue and a joint approach on cross border trade and all the elements related to it. This Committee looks into the possibilities of cooperating with the Albanian Diaspora in the U.S. It collaborates closely with the other Committees as well". The Trade and Investment Committee focused its work in 2019 on attracting foreign investments to Albania, forwarding to the relevant authorities the opinions and suggestions of AmCham members with the aim of improving the basic parameters of the country's business climate, which ultimately will help attract foreign investments. The Committee was very active in the lobbying process on the new Unified Investment Law, which is expected to be of fundamental importance to the business climate.









The mission of this Committee is to help members embrace the opportunity of the digital economy, to help leaders across private and public sector to explore and build the digital future. This committee would help to increase awareness and build a confidential environment where business executives can learn about its benefits, on how to implement the right strategies for the future and share best practices or their experiences with the other less advanced members. The Digital Business Committee would help companies develop a digital agenda for their own business, in order to capitalize on the opportunities of digitization and minimize the dangers of competition.

The Digital Business Committee is the most recently established Committee of the American Chamber of Commerce in Albania. The Committee's work in 2019 included an extensive analysis on how to have an impact in the development of digital processes, and, more specifically, the deployment of e-signature, the promotion of digital commerce and the training of businesses on technological innovations.



AmCham Business Index

The AmCham Business Index is one of the Chamber's most important publications as it reflects the opinion of its members on the business climate in the country and the level of ease with which businesses operate in the Albanian market. The AmCham Business Index provides a clear overview of the perception of our members of issues faced by them related to the country's economy, ranging from the most important factors of the business climate such as the level of corruption and informality to government policies affecting taxes and the businesses relationship with the tax authorities. The report's findings are very important to AmCham. Its' results help us guide and design the work plan and lobbying processes we should focus for the year.. In its seventh edition, AmCham Business Index noted that the business climate has seen a slight improvement of 0.71 percent, noting a more positive perception of business climate among members, while reflecting a deterioration of the Business Index in several areas. These included monopoly and unfair competition, internal political climate, overall tax levels and government bureaucracy.

In accordance with its bylaws, AmCham does not accept any financial aid from any government or subdivision thereof, or from any other source that would tend to prevent the Chamber from having freedom of action. This is how the Chamber preserves its independence and can best

serve its members.

The Chamber's expenses comprise administrative costs incurred from regular operations, costs of organizing and conducting activities, as well as costs for producing its publications.

AmCham is committed to administer the funds with which it is entrusted by its members with great accountability. AmCham strives to maintain a stable financial situation by keeping expenses lower than income and trying to close the year in a

financial position that is comparable to the previous year.

In 2018, as per the Board decision to streamline memberships according to the calendar year, AmCham member companies paid the pro-rated fee for the remainder of 2018 and that's why the closing position at the end of the year was different from the previous years.







