Mission

The Committee acts in line with the Albanian American Chamber of Commerce mission and objectives and by contribution of its members advances the Chamber's priorities. The Legal and Regulatory Committee reviews the developments in the main legal fields relevant for the US – related business activities in Albania and aims at improving national business climate through legal and policy suggestions. The Committee work is focused but not limited to the improvement of strategic investor and foreign direct investment climate, procurement, anti-corruption, competition, corporate and commercial legislation and business practice in Albania.

Through its work and active participation in meetings, forums and events, the Committee contributes to efficient, transparent and consistent implementation of laws and regulations that impact doing business across key sectors and industries of the Albania economy and rule of law. By doing so, it is a pillar of support for the Chamber's members.

The Committee is proactive in keeping an open channel of discussion with the Government (Council of Ministers and ministries of line) and relevant institutions for ensuring consistent interpretation and implementation of the company law framework. The Committee supports and promotes legal development and amendments that create value for the market, competitive advantage for companies and impact social and economic development.

- Work on transparency and predictability of the legislative process
- Work on effective justice and efficiency of judiciary as solid ground for domestic and foreign investors
